
**We have received your inquiry regarding your organization's federal tax exempt status.**

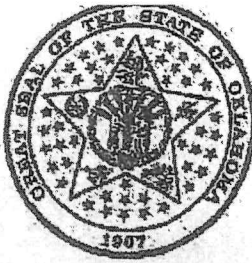

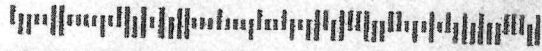
